The Future of Saxmundham - 2019 Household Questionnaire

Over the next 15 years or so, Saxmundham is likely to see big changes. The District Council has launched its "final draft" Local Plan, which proposes 800 new dwellings to the south of the town. EDF are also consulting on their proposals for a new nuclear power station at Sizewell.

To help meet the challenges, Saxmundham Town Council is working with local community volunteers to draw up a Neighbourhood Plan, which (if approved in a local referendum) can lay down local planning policies for Saxmundham which have legal effect.

As the Steering Group for the Neighbourhood Plan, we have already taken steps to consult widely, via public meetings, press, website and social media. But we are very keen to make sure that all residents are able to give us your views on key issues facing the town – e.g. the scale, location and types of new housing, the community facilities we need, and how to improve the town centre.




